The application fee is nonrefundable. (Processing of the application will start only after effecting the application fee by the laboratory)

Note 01

In case of foreign laboratories, fee will have to be paid in USD calculated as per the prevailing exchange rate.

Note 02

A sum calculated as 40% of the total assessor man-day charge (assessor man day charge multiplied by the number of assessors) will be charged separately as administrative expenses subject to a minimum of LKR 10 000.

Note 03

Local Assessments
