#### ASSESSOR TRAINING COURSE ON ISO/IEC 17043: 2010

The Sri Lanka Accreditation Board for Conformity Assessment (SLAB) as National Accreditation Authority in Sri Lanka introduced new accreditation scheme for Proficiency Testing Providers and one proficiency testing provider has been accredited as per ISO/IEC 17043 and two more applicants in the process of accreditation. Assessments of above applicants and accredited organizations were conducted in association with external expertise and SLAB assessors who are currently working with the SLAB. SLAB is planning to extend its international recognition for proficiency testing provider accreditation with the completion of one accreditation cycle of accredited proficiency testing provider.

For the accreditation scheme of Proficiency Testing Providers, SLAB expects to conduct an assessor training programme from 18<sup>th</sup> to 22<sup>nd</sup> March 2020 in order to train a batch of assessors in compliance with the International Standard ISO/IEC 17043:2010. Venue of the Programme is SLAB training room, No 104 A, Kithulwatte Road, Borella.

This programme will be conducted in association with the National Accreditation Board for Laboratories, India with the financial support of United Nation Industrial Development Organization (UNIDO) under the project titled, EU- Sri Lanka Trade – Related Assistance: Increasing SMEs' Trade Competitiveness in Regional and EU Markets.

The potential applicants need to successfully complete Assessors Training Course on ISO/IEC 17025: 2017. Applicants with training on ISO/IEC 17043 and experience in organization of inter- laboratory comparisons/ Proficiency testing programmes or similar activities and potential proficiency testing providers are encouraged to follow this programme in order to become a qualified assessor or accredited PT provider. Selection of participants will be done by an independent committee considering above mentioned criteria.

The prospective candidates should fill in and submit the attached Training reservation form along with application form, updated CV and supporting evidence for educational, professional qualifications and experience. Those currently employed are required to submit their applications with the concurrence of the Head of the Institution for release of such officials for the training and subsequent assessments. Applications shall be submitted to the SLAB by post to Sri Lanka Accreditation Board, No 104 A, Kithulwatte Road, Borella or email <a href="mailto:bandu@slab.lk">banduslab@gmail.com</a> on or before 2020-03-01.

A nominal training fee of LKR 20 000/= will be charged per participant to cover the cost. Number of participants of this programe will strictly be limited to 20.
