FEE STRUCTURE

Part 1 - Local Calibration Laboratories

1. Application fee for first accreditation and renewal of accreditation:

Application fee should be submitted with the completed application form. The application fee covers the cost of the process of evaluation of applicants' readiness for accreditation, and other administrative costs involved in processing of applications. The application fee is non-refundable.

Processing of the application will start only after effecting the application fee by the Calibration Laboratory.

First field of calibration up to 2 sub field of Calibrations*	LKR 60000
For each additional sub field of calibration under each field of calibration	LKR 10000
Application Fee for each additional Fields	LKR 60000

*Fields of calibrations are to be considered based on the fields given in the section 2.1 of Application for Accreditation of Calibration Laboratories (CL-FM(P)-01).

2. Application fee for scope extension/new field of accreditation:

Scope extension within the accredited field of Calibration	LKR 15000
Scope extension for New field of Calibration	LKR 60000

3. Assessor man day charges:

Assessor man day charge is applicable for Pre-assessment, Initial assessment, Surveillance assessment, Reassessment, Assessment for Scope Extensions, Witness assessment, Unannounced assessment and Follow-up assessment.

4. Annual Accreditation fee:

Annual Accreditation Fee for each field to be paid annually from the date of accreditation, as given below.

6. Local Calibration Laboratories with Foreign Accreditation

If the assessment is conducted in Calibration Laboratory operating in Sri Lanka on behalf of foreign accreditation body, fees relevant for foreign assessment will apply.

NOTES

Note 01

A sum calculated as 40% of the total assessor man-day charge (assessor man day charge multiplied by the number of assessors) will be charged separately as administrative expenses subject to a minimum of LKR 12 000.

When foreign assessors/experts used in assessments in addition to the assessor/expert man day charges, 45% will be added to man day charges.

Note 02

SLAB encourage the use of air travel for long distance travelling whenever available in order to minimize cost and efficient use of time.

- If travelling is on previous day/ day after the assessment or travelling on assessment day with stay overnight and the travel time is between 03-06 hrs, additional fee for 01 man day per assessor/expert will be charged.
- If travelling is on previous day/ day after the assessment or travelling on assessment day with stay overnight and the travel time is more than 06 hrs, additional fee for 02 man days per assessor/expert will be charged.
- If the travelling on the assessment day and the travel time is between 03-06 hrs, additional fee of 0.5 man day per assessor will be charged.
- If the travelling on the assessment day and the travel time is more than 06 hrs, additional fee of 01 man day per assessor will be charged.

1. Application fee for first accreditation and renewal of accreditation:

Application fee should be submitted with the completed application form. The application fee covers the cost of the process of evaluation of applicants' readiness for accreditation, and other administrative costs involved in processing of applications. The application fee is non-refundable.

Processing of the application will start only after effecting the application fee by the Calibration Laboratory.

First field of calibration up to 2 sub field of Calibrations*	USD 500
For each additional sub field of calibration under each field of calibration	USD 100
Application Fee for each additional Fields	USD 600

2. Application fee for scope extension/new field of accreditation:

Scope extension within the accredited field of Calibration	USD 150
Scope extension for New field of Calibrations	USD 500

3. Assessor man day charges:

Assessor man day charge is applicable for Pre-assessment, Initial assessment, Surveillance assessment, Reassessment, Assessment for Scope Extensions, Witness assessment, Unannounced assessment and Follow-up assessment.

Fee will have to be paid in USD.

Note 05

To conduct an assessment pertaining to activities of a calibration laboratory outside the country please refer section 3 of Part II.

Assessor man day charge will be calculated from the time of departure from Sri Lanka up to the time of arrival to the country, per assessor/expert.

A sum calculated as 40% of the total assessor man day charge (assessor man day charge multiplied by the number of assessors) will be charged separately as administrative expenses subject to a minimum of USD 200.

When SLAB use foreign assessors/experts in assessments, in addition to the assessor/expert fee, 45% of the total man day charge will be added

Note 06

All expenses of air travel, visa, airport taxes, transport, meals & lodging of assessment team and any additional charges from local authorities will have to be arranged by the Calibration Laboratory.

Note 07

All fees are subjected to applicable Taxes.
